

"What are your organization's greatest needs?"


Rank order 1 to 7






"What are your clients' greatest service needs?"

"What percentage of your organization's food is received as a food donation?"






"Which types of programs does your organization offer?"






"How do your clients find you?"





"How do your clients arrive at your site?"






"How many pounds of food are distributed monthly?"



"What is the total time your organization suspended services during COVID-19?"





"Select all food distribution methods that you have implemented before, during and after COVID-19."




"What were the most significant challenges you faced during COVID-19?"

Open ended question top responses 1 to 11





"Which factors prompted you to refuse food donations during COVID-19?"





Open ended question top responses 1 to 13




"Did you form any new alliances or partnerships during COVID-19 to secure additional resources? If so, what type of organizations participated?"
